Applications are invited for one number of Young Professional-II (YP-II) Interested candidates fulfilling the qualifications must submit their applications in the prescribed format along with self-attested copies of all the certificates, marksheets, Experience certificates etc. to the Director, ICAR-National Research Centre on Pig by speed post/email to (itmuicarnrcp@gmail.com). The complete application should reach the institute latest by **06-09-2024**.

The details of the posts including requisite qualification, remuneration and last date of application to be received are as under.

1. Name of the Project: NAIF Project, ITMU Section, ICAR-NRC on Pig, Rani, Guwahati
2. Qualifications: A. Master's degree in any branch of Life Science or Veterinary Science (M.Sc./M.V.Sc) from a recognized University/college
B. **Desirable:** Experience and expertise in intellectual property right (IPR) related matters
3. Age Limit: Minimum 21 Years and maximum 45 years (Age relaxation as per ICAR/Gol guidelines).
4. Duration: Initially for one year from the date of joining [extendable for two more Years (1year at a time) subject to the requirement of the services of the YP in the Institute and satisfactory performance of the candidate after evaluation by the Director of the Institute. However, maximum duration will not be extended beyond three years.
5. Emoluments: Consolidated remuneration of Rs. 42,000/-per month.
