How to reach

ICAR-National Research Centre on Pig Guwahati is located at a distance of 11 Km from Guwahati Airport, 25 Km from Kamakhya Railway station, 30 Km from Paltan Bazar Railway station, 28 Km from ISBT, Guwahati and 21 Km from Adabari Bus Stand, Guwahati. Participants may hire taxi at their own cost from these points to reach ICAR-NRC on Pig, Rani. Local conveyance is also available from Rani Gate to reach the Institute.

About NSSH

The National SC-ST Hub has been set up to provide professional support to Scheduled Caste (SC) and Scheduled Tribe (ST) entrepreneurs to fulfil the obligations under the Central Government Public Procurement Policy for Micro and Small Enterprises Order 2012, adopt applicable business practices and leverage the Stand Up India initiative. The Hub is being implemented by the National Small Industries Corporation (NSIC), a public sector undertaking under the administrative control of the Ministry of MSME.

About the programme

The one-month residential training programme will be conducted with financial assistance from the Ministry of MSME, National SC-ST Hub (NSSH), and National Small Industries Corporation (NSIC), New Delhi. This residential capacity-building programme on “Pig Farming” is an NSQF-compliant physical training program. Food and accommodation will be arranged by the Institute during the training. Transportation and local conveyance have to be arranged by the participants.

Eligibility

The application is open to aspiring and existing farmers and entrepreneurs belonging to SC and ST communities only. The minimum qualification is 10th pass. Candidates with higher qualification will be given preference in selection. Candidates with experience in pig farming, previous training exposure, association with FPOs, availability of funds through bank loans or state/centrally sponsored schemes, or similar ones will be preferred. The programme has been designed for farmers/ entrepreneurs who are into farming and for the unemployed youth with clear intent and interest in pig farming. Preference will be given to the candidates from aspirational districts. Special Preference will also be given to the female and divyang SC/ST candidates.
