Details procedures of availing medical facilities with the hospitals/ diagnostics centre shall be as per terms & condition of MOU (Term of MOU enclosed as Annexure- A). The employees must adhere all the procedures as indicated thereon.

ICAR-NRC on Pig, Rani, Guwahati will issue medical identity cards for the dependents of the employees, which shall be produced by them for availing medical treatments in the hospital/diagnostics lab. For availing Credit facilities from the hospital, the employees must obtained authorisation certificate from the Office.

Terms & Condition of MOU:

- The Agreement is subject to the detailed tariff schedule of the CGHS, Guwahati rates as on the date of signing of MOU as mutually accepted by both the parties and will be automatically revised as and when the CGHS Guwahati rates get revised by "CGHS", Ministry of Health and Family Welfare, Govt. of India.
- 2. Admission of ICAR NRC ON PIG, GUWAHATI employee or his /her dependent family member beneficiaries at the Hospital, will be governed by the Authorization Letter issued from ICAR NRC ON PIG, GUWAHATI to the Hospital Authority within nextworking day of his / her admission in the hospital by hand or by email whichever is easier and time saving. Office Identity Card and Medical Identity Card with details of family member issued by ICAR needs to be verified at the time of admission.
- 3. Class of accommodation as per entitlement of the employee and their dependent family member(s) will be mentioned specifically in the Authorization Letter Issued. The Hospital shall ensure that the medical treatment provided to the employees or their dependent family members are as per the specifications mentioned in the authorization letter.
- 4. Out- Patient- Department (OPD) Medical services shall be provided by "Hospital" to employees & dependents of ICAR- NRC on Pig, Guwahati as per the CGHS approved rates only.
- 5. All Diagnostic facilities shall be provided by Hospital/Diagnostic laboratory to employees & dependents of ICAR- NRC on Pig, Guwahati as per the CGHS approved rates only.
- 6. In-Patient Department(IPD) Medical services shall be provided by "Hospital" to employees & dependents of ICAR- NRC on Pig, Guwahati as per the CGHS approved rates only on credit basis and after completion of treatment of the patient, the Hospital shall send following documents to ICAR- NRC on Pig, Guwahati by speed post/ By hand and ICAR- NRC on Pig, Guwahati will make the payment within 30 days from the date of receipt of the following documents:
 - i. Duly filled up Certificate "B" as enclosed/ (Annexure- A).
 - ii. Discharge Certificate.
 - iii. Prescriptions slip/advise slip.
 - iv. Cash Memo/Bills in original with detail breakup signed by Hospital.
 - v. CGHS approved ratelist (For verification).
- 7. Payment against the bills submitted by hospital will be paid by ICAR- NRC on Pig, Guwahati after verification of bills and amount restricted as per CGHS approved rates if hospital charge higher amount than CGHS rates. The Payment made by ICAR NRC ON PIG, GUWAHATI to the Hospital will be inform to the Hospital by email along with the detail that will be verified by and acknowledge from the Hospital.

- 8. The hospital/ Diagnostic Centre shall provide information / clarification as requested by ICAR NRC ON PIG, GUWAHATI in respect of treatment availed by the employee or his dependent from the hospital/diagnostic centre at any time during the validity of the agreement and evenafter the expiry of the agreement, if the situation so warrants.
- 9. Hospital/ Diagnostic Centre shall charges the rates from the employees/ their dependents as per CGHS rates only and no additional charges/ rates shall be claims at later stage.
- 10.The Hospital/Diagnostic Centre shall also provide access to authorized person(s) duly appointed by ICAR NRC ON PIG, GUWAHATI upon written permission to the Hospital to examine and verify the medical records of the treated Employee/employee under treatment of ICAR NRC ON PIG, GUWAHATI. The hospital shall also provide copies of the indoor case papers of the employee without changing the document required for ascertaining the aliment / suffering / disease of the employee or heir dependent family member.
- 11. The Hospital/ Diagnostic Centre shall also provide access to the authorized employees for both cases on priority basis subject to available of beds/ Medical test facilities.
- 12. The Hospital/ Diagnostic Centre shall ensure that the employee is admitted to the Hospital is providing identify services on an urgent and preferred basis.
- 13. The particular MOU will be restricted to providing indoor patient treatment by the Hospital to the Employees of ICAR NRC ON PIG, GUWAHATI and their dependents as per CGHS rates on credit basis and out-patient treatment as per CGHS rates on cash basis.
- 14. Other hospital/ Diagnostic Centre facilities like Ambulance, Mineral water, Meals etc., if any availed by the employee or his dependent and which cannot be referred to the CGHS rates list or reimbursed under CGHS norms. Such charges will be collected by Hospital from the concerned employee at the time of discharge of the patient. Amount of such expenses should not be included in the credit bills of ICAR NRC ON PIG, GUWAHATI.
- 15. Any facilities provided by the hospital to the patient during the treatment which is not covered under CGHS, such facilities shall be charged from the concerned employee by the Hospital at the time of Discharge and the amount shall be excluded from the bills claimed from ICAR- NRC on Pig, Guwahati at later stage.
