If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. - 5. SCOPE OF WORK & TERMS AND CONDITIONS OF CMC OF AIRCONDITIONERS

The specifications/scope of work are mentioned hereunder:

- 1. All the Air Conditioners as listed in Annexure -A should be covered under this CMC maintenance contrac t
- 2. Under the CMC Contract, the Agency/Contractor shall maintain all Air Conditioners units as indicated in Annexure A in good working condition throughout the period of contract.
- 3. The CMC Contract includes replacement of faulty spares like Compressors, Starting Capacitors, Running Capacitors, Relays, Thermostats, Fan Capacitors, Fan Motors, Selector switches, Power Contactors, Control Contactors, External Time Switch Units provided for specific time running of A.C's, Stabilizers, Rewinding of motors, providing Ball bearing of motors, Fan blades, Electronic Control Circuitry, Remote Control units and

all other items which are required for the functioning of Air Conditioners at Agency/Contractor's cost. It als o include Gas charging and attending all complaints and breakdowns of all types of air-conditioners. Hence , the contract includes all cost of spares, gas filling charges etc which is required for functioning of Air Con ditioners and ICAR-NRC on Pig, Guwahati is not liable to pay the charges to contractor/agency beyond the contract amount.

- 4. The required tools and spare parts for carrying out the work shall have to be arranged by the Contractor at his cost and no tools will be arranged by this office.
- 5. The agency/contractor has to arrange necessary insurance coverage to the workmen deployed by him a nd shall arrange necessary safety measures before starting the work.
- 6. The agency/contractor shall make his own gas fillings, brazing, and welding arrangements in the place o f work at his own risk.
- 7. Sufficient stock of spare parts for all kinds of machines shall be kept in his stores. The contractor shall e nsure that no machine is idle due to non-availability of spare parts.
- 8. The agency/contractor shall deploy a minimum of two experienced mechanics with sufficient labour forc e at site to attend the day-to-day break downs and regular service.
- 9. The agency/contractor shall check all the machines twice in every month for their efficient operation.
- 10. The agency/contractor shall maintain all the machines in good working condition throughout the contra ct period. If any Air Conditioner as mentioned in the list is not functioning, the cost of repair of that Unit als o cover under the CMC contract and no additional charges will be paid by the institute. The agency/contra ctor are advised to visit the site prior to submission of their quote for the contract.
- 11. The maintenance of the machine shall be according to the preventive maintenance schedule.

Preventive Maintenance Services (PMS) Monthly: The monthly services include: Cleaning of air filters, indoo r unit grills & filters through air blower. Cleaning of the indoor unit body by wiping out the dust, etc., with w et cloth.

Preventive Maintenance Services (PMS) Quarterly:

Every machine shall be serviced at least once every quarter. A record of such services duly acknowledged by the person using the machine or in his absence, in charge of the location of the AC shall be maintained. Quarterly PMS shall include at least the following services:

Replacement of filter if found damaged/unusable.

Checking selector switch, thermostat, relays, remote control, etc.,

Checking motor bushings.

Checking ground connections.

Cleaning of blower and condenser fan.

Cleaning the evaporator & condenser coils.

Checking and tightening of nuts & bolts.

Oiling the motors.

Checking of the backup electrical power outlet/ MCB.

Checking of the drive motors and fans.

Over hauling of the AC, with chemical washing process.

Checking cooling efficiency.

Checking Firmness of the Supporting arrangement for the compressor, blower

motor, air conditioners casing and fixing of the air conditioners, etc.,

Replacement of any component of air conditioners (Outdoor and indoor units (including compressor), inlet

and outlet Pipelines (including copper pipes), electrical components, etc., found defective after the above c hecks and tests.

Charging of appropriate Refrigerant Gas during the period of Contract, if need arises.

Yearly Maintenance Services: The scope of work shall include all checks and tests as required under routin e maintenance services. In addition yearly maintenance services shall also include:

Cleaning the condenser and evaporator coils with suitable detergent/chemical solution and flushing with high-pressure jet of water. Greasing of blower motors and all moving parts.

- 12. CMC includes 2 routine visits every month as per the work requirement i.e. the service engineer shall v isit the site and shall inspect all the Air Conditioners twice every month. Further the firm has also to attend unlimited Emergency /on-call basis visits as when required as per requirement of the office without any ad ditional charges.
- 13. The rates to be quoted should be comprehensive annual maintenance rates and the payment shall be made to the firm on quarterly basis based after the satisfactory performance and compliance of all terms & conditions of contract.
- 14. The contractor shall have to provide stand-by air conditioner in working condition till such time the def ective AC taken outside for repairs is fully repaired and installed back to the satisfaction of the user. For this purpose, the contractor will be required to provide atleast two stand-by AC's (1-2 ton) immediately after the award of the contract to be kept in the ICAR, NRC on Pig, Guwahati premises till the contract is over.
- 15. The firm participating in the tender must be financially sound and well equipped having the required in frastructure to undertake the job. ICAR-NRC on Pig, Guwahati may satisfy itself with the financial soundnes s capability of the firm to undertake the job by physically inspecting the site of workshop and the offices et c. of the tendering firm before awarding the contract, if considered necessary.
- 16. During occurrence of contract, if any mishap occurs due to electrocution or faulty fittings, it will be the responsibility of the contractor to compensate the loss on account of injury to any person/property.
- 17. The contract will be awarded for a period of two year but can be extended with mutual consent. The te nder will be liable to be terminated even before the expiry of the contract period if the firm fails to provide satisfactory services or violates any of the conditions/terms of the contract. In that event, the security mon ey deposited by the firm will be forfeited. Besides, ICAR-NRC on Pig, Guwahati may make deductions upto 10 % while making payment of bills, if the services being provided by the firm are not satisfactory. The pay ment shall be released to firm on quarterly basis upon receipt of user satisfactory report.
- 18. Any repair of the AC shall be done at our office premises and will not be allowed to be carried out of the office for repair except in essential circumstances. The repair shall be

carried out within 02 working days and any further delay will make the firm liable to penalty clause of Rs.5 00 per day which shall be deducted from the bill itself.

- 19. Mode of Payment: ICAR-NRCP shall make payment through PFMS/ RGTS in favour of the agency.
- 20. Termination: This contract can be terminated by giving one month's notice on either side and that any notice required to be served shall be sufficiently served on the parties if delivered to them personally or di spatched at the address herein given under registered post. The ICAR-NRCP will not have any responsibilit y towards this for any damage/loss caused and it cannot be challenged in any court of law.
- 21. In case of any dispute arising, decision of Director, ICAR-NRC on Pig will be final.
- 22. GST & Other Taxes will be charged by the agency as applicable as per Govt. of India rules and are inclu sive in contract.
- 23. Director, ICAR-NRC on Pig reserves the right to reduce or terminate the period of contract or to extend its duration in the interest of the council/Institute for any justifiable reasons.
- 24. If the firm does not accept the offer, after issuing of letter of award by ICAR-NRCP within 15 days, the offer made shall be deemed to be withdrawn without any notice & EMD will be forfeited.
- 25. Evaluation of the quotation: The ICAR-NRCP, will evaluate and compare the quotation determined to be substantively responsive i.e., which are properly signed and fulfilled all the eligibility conditions. Financial b id will be opened of technically qualified firms. The ICAR-NRCP will award the contract to the responsive bi dder whose total cost for all the items put together is the lowest.

PREPARATION OF TECHNCIAL BID

The Technical bid shall contain following documents failing which the bids will be considered invalid and will be rejected.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
