Detailed specifications and scope of work

- A. Inspections render breakdown maintenance and regular preventive maintenance of all the components of the facility during normal working hours.
- B. The preventive maintenance will be done compulsorily "ONCE" in every quarter. CMC shall include unlimited breakdown calls.
- C. Preventive maintenance should include the following:
- ☐ Deep cleaning of HEPA Filters, Air Filters, Cooling Unit (air conditioning), and other startup items.
- ☐ Maintain required pressure, temperature, humidity in the facility and required air flow with alternative means if necessary.
- ☐ Check backup system & pressure network functions.
- ☐ The firm should take appropriate steps to maintain the required working environment conditions inside the facility.
- ☐ Any other item required for proper functioning of the facility should be covered and the firm should update the system accordingly.
- D. Comprehensive Maintenance contract will be inclusive of all the Items/Parts of the facility. Scope of Contract will include repair/replacement/update of all parts/network software.
- E. Comprehensive Maintenance contract will cover all cost involved for any purchase required for the replacement/repairs of the components, network Software of BSL2 facility,

Biosafety Cabinet/laminar air flow unit, UPS System/Power supply with batteries, Control Panel, switches, electrical wiring.

- F. Any customized application software in operation related to the facility should also be covered under this contract.
- G. Spare parts required for replacement under the contract, should be replaced with compatible, genuine and standard items only.
- H. The firm should truly and faithfully carry out Comprehensive Maintenance Contract of Biosafety Laboratory of ICAR-NRC on Pig, Guwahati in proper manner/standard fashion to the full extent and satisfaction of the customer for the period of one year from the date of signing of agreement. During the term of contract, the firm should extend all required technical support for maintaining the laboratory in good working order and for this purpose should provide all type of repair/replacement and maintenance service as and when required.
- I. Maintenance should be provided on site for the BSL2 facility by the firm. In case, the firm feels that the equipment cannot be repaired on-site, they may carry the defective equipment/part(s) with the consent of ICAR-NRC on Pig, Guwahati after giving due receipt of the equipment and delivered back the repaired equipment/part at the earliest at their own cost and risk.
- J. The Firm shall conduct Preventive Maintenance & general servicing (including but not limited to inspection, testing, satisfactory execution of all diagnostics, cleaning and removal of dust and dirt from the interior of the Equipment, checking and testing of UPS batteries and necessary repairing of the facility at least 4 times in a calendar year.
- K. The time for attending services in the BSL 2 facility shall not exceed 3 working days from the date of registration of complaint. The packing/unpacking, transportation, loading/unloading, connection/disconnection, configuration/re-configuration and any associated activity with the repair and maintenance of the BSL2 facility should be the sole responsibility of the firm.
- L. The firm should provide the list of the responsible technical personnel with details such as email/ mobile number who can be contacted by the Institute for any matter regarding the maintenance of the facility.
- M. The firm should provide service report(s) of each visit during the CMC period.
- N. The firm must undertake necessary steps to evaluate and certify for performance parameters of the facility by appropriate certified agencies annually without any additional cost as per the existing Biosafety regulations of the country. In addition, the firm should ensure that the

biosafety cabinet/laminar air flow unit present in the said facility should be validated once in 6 months without any additional costs.

ADDITIONAL NOTE

☐ Firms are advised to visit the site physically prior to participating in the bid for the assessment of the actual quantum of work, working condition of the lab and life expectancy of the spares and parts, so that if any machine/parts required to be replaced/repaired, the agency may calculate it's repairing/replacement cost and accordingly include total cost in the CMC contract.

TERMS & CONDITIONS PERTINENT TO THE TECHNICALITY OF THE FACILITY & SCOPE OF WORK

- 1. The firm should provide qualified technical personnel/service engineers, along with the details of their qualifications, for the maintenance of the BSL-2 facility. Copies of all relevant documents must be submitted. The institute reserves the right to request any additional documents from the firm for clarification at a later stage if found necessary.
- 2. The deputed technical personnel must carry an authorization document provided by the firm to carry out the necessary maintenance/repair work for the institute. This document should be presented to the authorized personnel of the institute upon request.
- 3. If the service is found unsatisfactory, the institute reserves the right to cancel the CMC with the firm at any time during the contract period without providing any reasons.
- 4. The technical personnel/Service Engineer of the firm should have successfully completed the appropriate professional training on maintenance of the biosafety facility from any reputed National/International agencies. Moreover, merely attending workshop/conference/symposia/membership certificate will not be considered. Copies of relevant documents should be submitted as proof.
- 5. The deputed technical personnel for carrying out the maintenance work at the biosafety facility should have necessary certificate as mentioned above and the details to be submitted to the office at the time of their visit.
- 6. The service providing agency should be responsible for providing all necessary safety accessories and measures required for the execution of the work to their deputed staff at their own expense. The Institute will not be responsible for any damage to the personnel deputed by the firm during the maintenance/repair work(s) at the institute.
- 7. The agency should not engage any subcontractor or sublet/transfer the contract to any other agency or individual in any capacity. The manpower deputed for work(s) at the institute must belong to their own firm.
- 8. The firm should have minimum experience of three years of AMC/CMC and

construction /repair work of BSL-2/3 facility/ABSL-2/ABSL3 facility of any Govt./PSU/University/Autonomous bodies/Reputed companies. Necessary copies of work order/agreement should be submitted.

9. During the operation and maintenance period, it is expected that the firm shall attend the breakdown and rectify the fault/s promptly with minimum possible downtime.

The maximum permitted DOWNTIME shall be 72 Hours from the time the intimation is given by the user.

If the repair/rectification is not carried out by the Contractor within the maximum permitted DOWNTIME, the Employer shall charge penalty, for each breakdown instance, subject to a maximum of 10% of the Annual Contract Value, as follows:

A. Above 72 hours & Below 168 hours - Penalty of 1% of the Annual Contract Value $\,$

B. Above 168 hours - Penalty of 1% of the Annual Contract Value + Additional Penalty for delay @ 0.5 % for each 24 hours.

The contractor shall maintain sufficient Inventory of required spares and consumables at site to minimize the downtime and to ensure smooth operation and functioning of the Laboratory.

Further, Liquidation charges for delay in execution/implementation of any terms & conditions of contract will be charged additionally @ 0.5 per Week and Maximum upto 10 %.

OTHER GENERAL TERMS & CONDITIONS

- 1. Mode of Payment: ICAR-NRCP shall make payment through PFMS/ RGTS in favour of the agency.
- 2. Termination: This contract can be terminated by giving one month's notice on either side and that any notice required to be served shall be sufficiently served on the parties if delivered to them personally or dispatched at the address herein given under registered post. The ICAR-NRCP will not have any responsibility towards this for any damage/ loss caused and it cannot be challenged in any court of law.
- 3. In case of any dispute arising decision of Director, ICAR-NRC on Pig will be final and binding.
- 4. GST & Other Taxes will be inclusive in the contract value at the prescribed rates as per Govt. of India rules/guidelines.
- 5. Director, ICAR-NRC on Pig reserves the right to reduce or terminate the period of contract or to extend its duration in the interest of the council/Institute for any justifiable reasons.

- 6. EMD Amount of Rs 50,000/- shall be submitted by the bidder. If the firm is exempted, necessary documents i.e., the firm having MSME/Startup firm registration certificate under the respective category to be uploaded.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in
