If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. The specifications/scope of work are mentioned hereunder:

- 1. All the Computers and Peripherals as listed in Annexure A should be covered under this Comprehensive maintenance contract (CMC).
- 2. Under the CMC Contract, the agency/contractor shall maintain all Computers & Peripherals as listed in A nnexure A in good working condition throughout the period of contract.
- 3. CMC Includes weekly 02 visit on official day during the period of contract. However, if required the agen cy may be asked to visit on other days as per requirement without payment of additional charges.
- 4. The CMC includes formatting of computers, data recovery and re installation including maintenance of s oftware being used in this office.

- 5. Whenever the system cannot be repaired on site within the specified time limits, the company will have the option to take the equipment to their workshop/premises with prior approval and provide alternate equipment of matching specification. This Department equipment in any case will have to be repaired/set right within 05 days and installed in the office. The firm will arrange their own transport for which no extra pay ment will be made.
- 6. Penalty for not attending the calls beyond 48 hours will be Rs 500.00 per call per working day for any of the items covered under the contract.
- 7. CMC amount will be paid in 04 equal instalments at the end of each quarter subject to satisfactory performance and compliance of all terms & conditions of CMC Contract. However, 100 % payment may be mad e on submission of equal amount PBG, which is to be valid throughout contract period.
- 8. For UPS only Internal Batteries are included in CMC. For any problem in External Batteries the Institute will arrange for it separately.

- 10. Mode of Payment: ICAR--NRCP shall make payment through PFMS/ RGTS in favour of the agency.
- 11. Termination: This contract can be terminated by giving one month's notice on either side and that any notice required to be served shall be sufficiently served on the parties if delivered to them personally or di spatched at the address herein given under registered post. The ICAR--NRCP will not have any responsibilit y towards this for any damage/loss caused and it cannot be challenged in any court of law.
- 12. In case of any dispute arising, decision of Director, ICAR--NRC on Pig will be final.
- 13. GST & Other Taxes will be paid as applicable as per Govt. of India rules.
- 14. Director, ICAR--NRC on Pig reserves the right to reduce or terminate the period of contract or to extend its duration in the interest of the council/Institute for any justifiable reasons.
- 15. If the agency/contractor does not accept the offer, after issuing of letter of award by ICAR--NRCP within 15 days, the offer made shall be deemed to be withdrawn without any notice & EMD will be forfeited
- 16. Evaluation of the quotation: The ICAR--NRCP, will evaluate and compare the quotation determined to be substantively responsive i.e., which are properly signed and fulfilled all the eligibility conditions. Financial bid will be opened of technically qualified firms. The ICAR--NRCP will award the contract to the responsive bidder whose total cost for all the items put together is the lowest.
- 18.Terms of the contract:

A. The contract will be for two (2) years. On the expiry of the contract or on its termination, the ICAR--NRC P reserves the right to renew the contract on quarterly /half yearly / yearly basis on the terms and conditio ns that may then be mutually agreed upon.

- B. The income tax etc. as applicable will be deducted from the claim of the contractor at source.
- C. The Agency/Contractor is also to abide with the rules of ICAR/ Govt. of India.
- 19. The Agency/Contractor should be well experienced and should have provided AMC/CMC services of computers/IT related works in any (02) two Government /Semi Government/Government funded Institution in last 05 years and shall also submit satisfactory performance report. The agency shall enclose work order copies along with satisfactory performance report. No exemption is provided to the MSME/Startup firms considering the critical security operations related to information technology equipments in accordance with MoF OM No. F.20/2/2014--15/PPD(Pt.) dated 20.09.2016.
- 20. EMD Amount of Rs 20,000/-- shall be submitted by the bidder.
- 21. Performance Security of an amount equivalent to 5 % of the total contract value has to be deposited by the agency within seven days of intimation of the award of the work.
- 22. The amount of Performance Security money will be refundable without any interest after 2 months of s uccessfully completion of the contract period.
- 23. The Performance security money can also be utilized to recover any loss/damages faced by the institut e due to poor service/not attending service within the stipulated timeframe.
- 24. No interest will be paid against EMD and security deposit.
- 25. The agency/contractor should have its registered office in Guwahati for providing continuous service. Documentary proof in this regard needs to be submitted.
- 26. The Bidder must quote a lumpsum amount for 24 months period i.e. for 2 years.
- 27. The Guwahati High Court will have the jurisdiction to deal with any legal matters or dispute.
- 28. The Agency/Contractor shall have to provide stand--by computer & peripherals in Working Condition till such time the defective Computer & peripherals taken outside for repairs is fully repaired and installed back to the satisfaction of the user. For this purpose, the contractor/agency will be required to provide atle ast 2 stand--by computers, 5 stand--by UPS, 2 Printers immediately after the award of the contract to be k ept in the ICAR--NRC on Pig, Guwahati premises till the contract is over.
- 29. The agency/contractor shall maintain all the machines in good working condition throughout the contract period. If any Computer/Peripherals as mentioned in the list is not functioning, the cost of repair of that Unit also cover under the CMC contract and no additional charges will be paid by the institute.
- 30. The agency/contractor are advised to visit the site prior submission of their quote for the contract.
