1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

- 7. All samples have to be picked-up from ICAR-NRC on Pig, Rani, Guwahati, Assam and the cost shall be included in the total quoted amount.
- 8. Payment will be made only after satisfactory completion of work, receipt of data and reports

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
