- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. Scope of Work And Terms and Condition of Contract

- 1. The quantity mentioned in the bid for Compound Pig Feed is tentative or the period of one (01) year however, the actual order quantity may hange as per the requirement and the firm has no right to claim in this regard.

- 2. The items should be supplied at ICAR-National Research Centre on Pig, Rani, wahati, Assam-781131
- 3. The rate should be quoted FOR ICAR-NRC on Pig, Rani, Guwahati including of all duties, taxes, loading charges, unloading charges, charges of weighing bridge of each consignment, charges of sample testinof each consignment and transportation charges upto the destination f consignee location i.e ICAR-NRC on Pig, Rani, Guwahati-781131.
- 4. All losses during transit due to breakage and shortage etc. will have to be born by the **Firm/Agency** at his own cost.
