- 5. Undertaking indicating Non blacklisting of the service provider by Government or autonomous organizations/ institutions Universities etc.
- 6. A copy of the terms and conditions signed by the bidder to be uploaded in the GEM portal, implying compliance and agreement.
- 7. Three work order copies within past two financial years undertaking quoted service from any Government institutions.
- 8. Annual Turnover Certificate for the last 3 financial years signed by the C.A with UDIN No. indicating a turnover of at-least 50% of the Bid Value.
- 9. Documentary proof regarding having the in-house facility for quoted service and bioinformatics team for analysis of data in India should be submitted.
