TERMS AND CONDITIONS OF CONTRACT AND SCOPE OF WORK

Complete CMC of Water Purification/Water Filtration Units as per Annexure I.

1. Scope of Maintenance work will include the following:

A. Replacement of consumable/chemicals, media items etc as mentioned in Ann exure-I for Water Purification System (SL.No. 01 and 02) shall be done once in e very year, preferably in the first month of CMC of every month.

B. Replacement of RO membrane, Sediment filter, Spun Candle, Carbon filter et c. In all water filtration unites as mentioned in Annexure I, SL.No. 03 once in a y ear

C. CMC cover the cost of replacement of spares/repairs and all accessories as an d when required to make the water purification system functional throughout th e year.

D. The water tanks shall be periodically cleaned and maintain hygienic througho ut the year.

E. Periodical maintenance once in a month (12 times/year).

F. Breakdown calls as and when required.

G. Replacement of any electronic unit/circuit associated with each unit.

2. To attend services calls other than mandatory service call, as and when required within 12 hrs from the time of call registered.

3. Servicing reports shall be submitted for every visit/ every breakdown calls.

4. No revision in rate (on higher side) will be accepted during the CMC period.

5. Comprehensive Annual Maintenance contract will be inclusive of all the Items/ Parts of the Equipment.

6. Spare parts required for replacement under the contract, shall be replaced with compatible, genuine and standard items only.

7. Payment under the contract will be made at the end of each quarter/halfyearl y subject to satisfactory performance of the firm and on submission of service re port along with bills in triplicate form.

8. Firms are advised to visit the site physically prior participating in th e tender for the assessment of actual quantum of work, working condit ion of the systems and life expectancy of the spares and parts, so that if any parts required to be replaced/repaired, the agency may calculate it's repairing/replacement cost and accordingly include total cost in the contract.

9. The firm shall truly and faithfully carry Comprehensive Annual Maintenance C ontract of water filtration/water purification system of ICAR-NRC on Pig, Guwaha ti in proper manner/standard to the full extent and satisfaction of the customer f or the period of three years from the date of signing of agreement. During the te rm of contract, the firm shall maintain all water filtration/purification system in g ood working condition and for this purpose the firm needs to provide all type of r epair/replacement and maintenance service.

10. Maintenance contract is comprehensive, which covers both the replacement of spare parts and labour.

11. The maintenance shall be carried out primarily at the premises of ICAR-NRC on Pig, Guwahati during the office hours. In case, the firm feels that the equipme nt cannot be repaired on-site, they shall suggest corrective action to repair the s ame. With the consent of ICAR-NRC on Pig, Guwahati the damaged/ defective eq uipment/parts may be taken outside for repair after giving due receipt of the eq uipment and delivered back the repaired equipment at their own cost and risk.

12. The present water purification/filtration system at ICAR-NRC on Pig,

Guwahati are quite satisfactory and the firm shall not raise any condition with re gards to the working condition for the items covered under the Maintenance Co ntract.

13. The firm shall maintain/provide uninterrupted service to ICAR-NRC on Pig, Guwahati during the period of the contract.

14. The firm shall depute the Qualified Maintenance engineers for servicing who is totally familiar with the work.

15. If the calls are not attended within 02 working hour and the service s are not attended within one day, penalty for not attending calls/servi ces will be charged/deducted from the bills of the firm by ICAR-NRC on Pig, Guwahati @ Rs. 2000.00 per day from the specified time considerin g the earlier period of non-compliance.

16. The firm shall maintain log book and shall record therein each incid ent, date and time of commencement and successful completion of rep air work and nature of repair work performed at the Customer's site.

17. "CMC contract will be upto maximum period of 03 years, however the performance of the firm will be reviewed at th e end of each year and if the performance is found satisfact ory then only the CMC contract will be considered for contin uation otherwise it will terminated".

18. The Contract shall be governed by Indian Law and both the parties' consent to the jurisdiction of Gauhati High Court in all matters.

19. The firm awarded the contract shall submit performance Securi ty Money @5% of Contract Value. The performance security money will be retained till the completion of the contract.

20. The amount of performance security money will be released wit hout interest subject to satisfactory performance of the contract.

21. If, the performance of the firm was found unsatisfactory durin g the contract period or the firm breach any condition of the contr act, the performance security money submitted by the firm will be forfeited by the Institute i.e ICAR-NRC on Pig, Guwahati and neces sary penal action as per the discretion of Director, ICAR-NRC on Pig , Guwahati may also be taken against the firm.

- 1. Mode of Payment: ICAR-NRCP shall make payment through PFMS/ RGTS in f avour of the agency.
- 2. Termination: This contract can be terminated by giving one month's notice on either side and that any notice required to be served shall be

sufficiently served on the parties if delivered to them personally or dispatched at the address herein given under registered post. The ICAR-NR CP will not have any responsibility towards this for any damage/loss caused and it cannot be challenged in any court of law.

- 3. In case of any dispute arising, decision of Director, ICAR-NRC on Pig will be f inal.
- 4. GST & Other Taxes will be paid as applicable as per Govt. of India rules.
- 5. Director, ICAR-NRC on Pig reserves the right to reduce or terminate the peri od of contract or to extend its duration in the interest of the council/Institut e for any justifiable reasons.
- 6. Incomplete tender or not complying with the above condition is liable to be rejected. Overwriting or figures written in such style that it can be read in more than one way lead to cancellation of tender.
- 7. The Bids received after due date and time will not be entertained.
- 8. If the date upto which the tender is open for acceptance is declared to be a holiday the tenders shall be deemed to remain open for acceptance till the next working day.
- 9. No interest will be paid against EMD.
- 10. If the firm does not accept the offer, after issuing of letter of award by ICA R-NRCP within 15 days, the offer made shall be deemed to be withdrawn without any notice & EMD will be forfeited.
- **11. 
