- 1. Last date of submission of online tenders is 07-09-2021, 11.00 A.M. and Technical bids will be opened on 08-09-2021, 11.00 A.M.
- 2. The interested bidders are required to compulsorily deposit the Tender Fees of Rs. 500.00 (Rupees Five Hundred) and Earnest Money Deposit (EMD) of Rs. 10,000.00 (Rupees Ten Thousand) in any of the following ways:
 - a. Deposit to Institute Bank Account Directly
 - Bank Account No. 10029420452, State Bank of India, Bank Account in Name ICAR NR Center on Pig Payable at SBI, Khanapara Branch (IFSC CODE- SBIN0009945IN). Bidders after depositing the amount must upload deposit slip/proof of depost alongwith technical bid documents as specified in the tender in CPP portal.

TERMS & CONDITIONS OF THE CONTRACT

- 1. Mode of Payment:
 - ICAR-NRC on Pig shall make payment through PFMS/ RGTS in favour of the agency.
- 2. Termination: This contract can be terminated by giving one month's notice on either side and that any notice required to be served shall be sufficiently served on the parties if delivered to them personally or dispatched at the address herein given under registered post. The ICAR-NRCP will not have any responsibility towards this for any damage/ loss caused and it cannot be challenged in any court of law.
- 3. The contractor is advised to do a complete survey to assess the site and quantum of work of the tender prior submitting the rates/ submission of tender.
- 4. In case of any dispute arising, decision of Director, ICAR-NRC on Pig will be final and binding.
- 5. An amount of Rs. 25,000.00 (Rupees Twenty Five Thousand Only) is to be deposited by the selected/ successful tenderer as a security deposit only after receiving communication from the ICAR-NRC on Pig. In the event of non –deposition of the same, the earnest money will be forfeited.
- 6. GST & Other Taxes will be pad as applicable as per Govt. of India rules.
- 7. Director, ICAR-NRC on Pig reserves the right to reduce or terminate the period of contract or to extend its duration in the interest of the council/Institute for any justifiable reasons, not mandatory to be communicated to the tenderer.
- 8. Incomplete tender or not complying with the above condition is liable to be rejected. Overwriting or figures written in such style that it can be read in more than one way lead to cancellation of tender.
- 9. The tender received after due date and time will not be entertained.
- 10. If the date upto which the tenders is open for acceptance is declared to be a holiday the tenders shall be deemed to remain open for acceptance till the next working day.
- 11. No interest will be paid against EMD and security deposit.
- 12. The Agency shall follow the provision of all labour laws applicable to this establishment including statutory payments and other liabilities / eventuality labourers from time to time and will be solely responsible. ICAR-NRC on Pig, Guwahati will not have any responsibility in this regard in any case/ eventuality.
- 13. If a tenderer does not accept the offer, after issuing of letter of award by ICAR-NRCP within 15 days, the offer made shall be deemed to be withdrawn without any notice & EMD will be forfeited.
- 14. The contractor / Agency shall make payment of remuneration / wages to its personnel before 7th of every month and if required ICAR-NRCP, Rani, Guwahati may asked the firm to produce a copy of payment vouchers of the workers employed by the agency. The entire cost and liability of any material or other, losses due to negligence from part of successful bidder or the persons engaged will be borne by the contract awarded firm

- 15. The personal engaged by the agency for this job contract will not be an employee of the council/ICAR-NRC on Pig and there will be no employer- employee relationship between the council/ICAR-NRC on Pig and the personnel so engaged by the contractor.
- 16. The agency shall be wholly responsible for making payment of monthly salaries and other admissible allowances to the personnel under minimum wages act and the council/ICAR-NRC on Pig shall in no way be responsible for meeting any kind of expenditure on salaries etc. to these personnel individually.
- 17. **Evaluation of the quotation**: The ICAR-NRC on Pig, will evaluate and compare the quotation determined to be substantively responsive i.e which are properly signed and fulfilled all the eligibility conditions. Only those firms will be considered for financial bid opening who will qualify in the technical bid. Financial bid will be opened of technically qualified firms. The ICAR-NRCP will award the contract to the responsive bidder whose total cost for all the items put together is the lowest. **Terms of the contract**:
 - 1) Initially the terms of the contract will be for one year. On the expiry of the contract or on its termination, the ICAR-NRC NRC on Pig reserves the right to renew the contract on quarterly /half yearly / yearly basis on the terms and conditions that may then be mutually agreed upon.
 - 2) The income tax etc. as applicable will be deducted from the claim of the contractor at source.
 - 3) All the statutory rules with regard to labour management and other liabilities have to be adhered to by the contractor/firm.
 - 4) The contractors/Firm is also to abide with the rules of ICAR/ Govt of India.
 - 5) All the labour liabilities in respect of the labourers engaged by the contractor/firm as per labour law rest with the labour contractor/firm. The rate may be quoted after taking into account all the statutory payment as per labour laws i.e EPF, ESI, Leave, Bonus and Service Charges etc.
 - 6) The Director, ICAR-NRC NRC on Pig, Guwahati reserves the absolute right and power of revoking or cancellation of the job contract Basis with one month notice without assigning any reason whatsoever.
 - 7) The contractor shall pay the minimum wages as per Central Govt Rate to the persons to be engaged by him as per labour laws revised from time to time.
